NOTE:

We are conducting investigation concerning subject and his wife, Ruth Paine, at the request of the President's Commission. Reverend and Mrs. Anthony Paul Treasure were allegedly present during 1950 discussion between the families of Michael and Ruth Paine. Subject reportedly was also present and during this discussion various statements were allegedly made to the effect that the Korean War was all a mistake and that the U. S. would be better off if the communists took over and that we should permit this rather than fight the communists. The Treasures are reportedly residing in England and Legat is attempting to determine their location for interview regarding the above-mentioned discussion. This communication will be sent through State Department channels at no cost to the Bureau.
