A confidential informant, ~~who is in the position~~
~~to furnish reliable information but~~ contact with whom has
been insufficient to determine the reliability of ~~his~~
~~information~~ during January, 1967, advised that in connection
with the assassination of President John Fitzgerald
Kennedy, it was concluded by the KGB Headquarters in
Moscow that he was killed by representatives of a group of
monopolists connected with the south and the east of
the United States. This group of monopolists, ~~was~~
characterized as the military-industrial complex, ~~and~~
that Kennedy had tried to limit their activities and
hurt their interests and therefore ~~was assassinated.~~
they planned his assassination

Informant advised that this conclusion was
drawn after the KGB had spent between six months and a year
to study information to determine the cause of the
assassination. Source stated that the most reliable
KGB agents in the world were mobilized, in addition to
other official contacts in order to gather, in a wide
scope, information concerning the reason for the
assassination. (S)(u)

A group of officers under ~~Vasili Sinitkov~~ in Moscow
carefully gathered the information and conducted extensive
research and analysis and came to the conclusion that it was
the military-industrial complex who were responsible for the
death of Kennedy. (S)(u)

Source further identified Vasili ~~Romanovich Sinitkov~~ as the Chief
of a sector, Information Section, International Department, Central
Committee of the Communist Party of the Soviet Union. (S)(u)
