**PASSENGERS ON THE FEEDER BUS WHO BOARDED BUS NO. 332 at SAN LUIS POTOSI on 10/2/63.**

Sr. ZENOBIO ASCENCIO has a small clothing shop at Calle Allende No. 11, Aguililla, Michoacan, Mexico. Sr. ASCENCIO stated that he has a friend named CECILIO CARDENAS CISNEROS who lives at a lumbering village called Dos Aguas nearby. It was ascertained at Dos Aguas that CARDENAS has a small tailor shop and is also a distributor of Singer sewing machines in the area.

CECILIO CARDENAS was located at Rancho En Medio, Municipality of Coalcoman, Michoacan, and upon interview stated that he was born in the Municipality of Aguililla on 7/12/1933 being the son of MARGARITO CARDENAS PRADO and MARIA INES CISNEROS. CECILIO resides at Dos Aguas with his wife SOFIA GUIZAR de CARDENAS and four children.

CECILIO CARDENAS stated categorically that he did not board any bus in San Luis Potosi at any time in 1963 since he not left that area in Michoacan for a long time. He did state that he was in the United States several years ago but has now been living in Michoacan for several years. He also stated that he has seen photographs of OSWALD in newspapers but has never seen such a person.

Sr. ELIAS GARIBAY of Uruapan, Mich., District Manager of Singer Sewing Machine confirmed that CARDENAS made no trips to Monterrey, N.L. in 1963.
