IKE CLARK, former employer of subject, advised that JEANNE DE MOHRENSCHILDT once worked for Dan River Mills in New York City before coming to Dallas. This employment was actually by DAN MILLSTEIN and has been verified by New York.

By letter dated 3/4/64, the Legat, Rome, advised the Bureau that check with established criminal and security sources did not reveal any information concerning subject and her possible travel to Italy. Checks were made with (1) It. Col. VITTORIO MENEGUZZER, Italian Armed Forces, Intelligence Service/(5)(2) Dr. FEDERICO D'AMATO, Division of Confidential Matters, Italian National Police, (3) Dr. ARISTIDE MANOPULO, Central Bureau, Criminal Division, Italian National Police.

It is noted that inquiry of the First National Bank in Dallas disclosed that subject opened a checking account there on 2/1/57 with a deposit of \$1,280.60, including a check drawn on the First National Bank, Chicago, Illinois, under the name JEANNE LE GON. Records of the First National Bank in Dallas do not contain a microfilm of the checks opening her account, and the only record maintained is a deposit slip listing the bank transit numbers.

By teletype dated 3/13/64, Chicago advised that the cardex files of the First National Bank in Chicago contained no information concerning the subject, indicating no account was ever opened under her name. The bank maintains no microfilm records and could not now determine if a check payable to subject had been drawn on that bank. None of the persons interviewed in connection with this investigation have furnished any information to indicate subject ever lived in Chicago and there appears to be no additional logical investigation which might disclose the source of the above money. Accordingly, no further inquiry is being conducted in this regard.
