Remyairtel 12/5/63, setting forth the results of interview of ALEKSANDER IVANOV. Bureau was informed [MI-5] was conducting investigation of IVANOV and contemplated immediate interview with him.

There is enclosed for the Bureau, the original copy of the interview conducted by [MI-5] on December 5, 1963. [MI-5] stated that if the Bureau desired they would be happy to interrogate IVANOV at greater length. A copy of results of this interview has also been furnished to CIA, London.
