LEE HARVEY OSWALD

Bureau airtel 4/23/64 instructed WFO to be alert through established coverage to the possible future visit by Mrs. MARGUERITE OSWALD to the Soviet Embassy. [WFO has effected coverage through appropriate established sources such as lookouts, confidential informants and anonymous sources.] (S)(u)

The attached report is classified "Confidential" because it reveals our investigative interest in a representative of a foreign diplomatic establishment; and further because it contains information from WF T-1, a confidential source of continuing value, which if disclosed could tend to identify the source and thus compromise its effectiveness. (S)(u)

~~It is also classified "Confidential" to protect the identity of WF T-2 since disclosure of information attributed to PAUL BETHEL might ultimately lead to informant's identity and thus compromise his possible future value.~~
