The attached report is classified "Confidential" because it reveals our investigative interest in a representative of a foreign diplomatic establishment; and further because it contains information from WF T-I, a confidential source of continuing value, which if disclosed could tend to identify the source and thus compromise its effectiveness.

It is also classified "Confidential" to protect the identity of WFT-2 since disclosure of information attributed to PMS-DEFINE right withmately lead to informant's identity and thus compromise his possible future reluction.
