FOLLOWING IS DAILY SUMMARY:

RE ALLEGATIONS OF PEDRO GUTIERREZ VALENCIA. CIA HERE TODAY ADVISED REVIEWED RESULTS PHOTO SURVEILLANCE AT CUBAN EMBASSY FOR PERIOD SEPTEMBER AND OCTOBER LAST WITH SPECIAL EMPHASIS ON DATES SEPTEMBER 30 TO OCTOBER 4, COMPARING PHOTOGRAPH OF GUTIERREZ WITH PHOTOS OF PERSONS VISITING CUBAN EMBASSY DURING PERIOD DESCRIBED. CIA UNABLE TO IDENTIFY GUTIERREZ AS VISITOR CUBAN EMBASSY DURING THAT PERIOD AND CIA OFFICIAL VOICED BELIEF THAT GUTIERREZ WOULD HAVE CERTAINLY BEEN PHOTOGRAPHED IF HE HAD IN FACT EXITED CUBAN EMBASSY ON OCTOBER 1 LAST BETWEEN 10:30 AND 11:00 AM AS GUTIERREZ CLAIMED.

CIA ALSO TODAY MADE AVAILABLE THREE PHOTOGRAPHS OF UNIDENTIFIED POSSIBLE AMERICAN FLOWN TO DALLAS ON NOVEMBER 23 LAST BY SA ELDON D. RUDD AS WELL AS 20 PHOTOS OF POSSIBLE AMERICANS PHOTOGRAPHED AT CUBAN EMBASSY HERE DURING SEPTEMBER AND OCTOBER LAST FOR EXHIBIT TO GUTIERREZ.

CIA INFORMED PERSONNEL ON PLANT AT CUBAN EMBASSY HERE UNABLE TO IDENTIFY DINA RENAULT AUTOMOBILE WHICH ACCORDING TO GUTIERREZ STORY WAS ENTERED BY CUBAN AND AMERICAN NEAR CUBAN EMBASSY ON OCTOBER 1 LAST.

MEX-46 RELIABLE, TODAY REPORTED GUTIERREZ HAS OCCUPIED APART-4

PAGE THREE FROM LEGAT MEXICO CITY NO. 389, 390

POINTED OUT TO ROJAS HE ATTRIBUTED THEM TO HIS "POOR EDUCATION" AND SHRUGGED THEM OFF. IT IS FELT HE MIGHT ADOPT DIFFERENT ATTITUDE IN PRESENCE OF POLICE AUTHORITIES OF HIS OWN COUNTRY. RECOMMENDATION FOR INTERVIEW BY MEXICAN AUTHORITIES NOT MADE PREVIOUSLY AS IT WAS FELT THAT SUCH INTERVIEW MIGHT AFFECT RESULTS OF POLYGRAPH EXAMINATION. SINCE LATTER NOT BEING GIVEN THERE WOULD APPEAR TO BE NO OBJECTION TO INTERVIEW BY MEXICAN AUTHORITIES NOW. u

RE PERSONS WHO DEPARTED FROM NUEVO LAREDO OCTOBER 3 LAST DURING SHIFT FOLLOWING DEPARTURE OF OSWALD. COPIES OF MEXICAN IMMIGRATION FORM FM-11 FURNISHED BY RAFAEL HERNANDEZ OCHOA BEING FORWARDED POUCH TOMORROW. HERNANDEZ OCHOA ADVISED TODAY HE EXPECTS TO COMPLETE OBTAINING OF MEXICAN TOURIST CARDS ON WHICH FM-11 BASED NO LATER THAN TOMORROW. LETTERHEAD MEMO INCORPORATING INFORMATION CONTAINED IN TOURIST CARDS WILL BE SUBMITTED IMMEDIATELY THEREAFTER AND APPROPRIATE LEADS WILL BE SET FORTH FOR DOMESTIC OFFICES. u

SOURCES ALSO RECONFIRM THAT SMALL DOES NOT SELL POST CARDS IN HIS STORE. u
