On 1/27/69, [NY 554-S*] furnished information indicating that above Soviet correspondents planned to depart New York for New Orleans at 9:05 AM, on 1/30/69, via Eastern Airlines Flight 69. This flight is scheduled to arrive in New Orleans at 11:13 AM.

LOSEV will be accompanied by his wife and child while BOROVIK will be alone. LOSEV has a seat reserved for the Clay Shaw trial and both have rooms reserved at the Capri Motel, Phone 504 822-2161. They intend to request authority for return trip on Saturday, 2/8/69, however, LOSEVs are travelling family plan, which requires travel on a weekday. The return date is therefore uncertain at present.

As it appears that LOSEV will attend the Shaw trial on legitimate press business, New Orleans should verify his attendance at the trial and afford additional coverage. ~~(S)~~ (u)

BOROVIK has no reservation for above trial and has visited New Orleans in the past. He should therefore be afforded surveillance coverage to ascertain the purpose and nature of his visit and to identify his contacts. It should be noted that he has proved in the past to be very surveillance conscious. ~~(S)~~ (u)

Submit results of investigation in LHM form, eight copies to Bureau. Classification should be, "Secret - No Foreign Dissemination" due to the sensitive nature of NY 554-S* ~~(S)~~ NYO will cover departure and advise if there is any deviation from original plans. ~~(S)~~ (u)

Both above subjects are affiliated with the KGB, however, established source coverage only is requested on LOSEV as the purpose of his visit is known. Fisur is requested on BOROVIK as the purpose of his visit is not known. New Orleans has previously received photos of BOROVIK. ~~(S)~~ (u)
