Enclosed is a photograph of a letter from subject received under confidential classification from the Confidential Communications Intercept Service (CIS). This information is from a highly sensitive source and the source must be protected. If any information from this source is furnished to a foreign agency it must be carefully paraphrased to protect the source. (C)

"Dear Mr. Pahl:

"Thank you for your airtel of March 25th. 'New Germany Reports' are still being published, but irregularly because of the increasing pressure of other writing commitments. Since last November, all my time has been taken up by a new book. I have written about the assassination of President Kennedy (see enclosures). (C)

"However, I am still hopeful of getting out two or three 'New Germany Reports' this year. (C)

"I do not know which is the last number of NGR you have received. According to my records, Nos. 60-61 ('The Francup of Capt. Kauffman') and No. 62 ('Those German Rocketeers in Egypt') were shipped to you in September and October 1963. If you did not get either one, or both, of these reports, please let me know and I'll mail substitute copies. (C)

"Whenever further reports are published in this series, you will get them. (C)

"P.S. As I am leaving for the country today, please address your reply as follows: Joachim Joesten, S.R. 262, Great Barrington, Mass., USA." (C)

The enclosure to subject's letter is identical to that received anonymously by the Bureau which was furnished to Dallas, New York and Legats by C-7 from the Bureau dated 4/18/64 in Bufile 62-109000. A copy of this enclosure captioned "The Joesten Report; The Truth About the Assassination of President John F. Kennedy" received anonymously by the Bureau was postmarked at Great Barrington, Massachusetts on 4/8/64. The P.S. to subject's letter gives an address as S.R. 262 Great Barrington, Massachusetts.

Subject was interviewed by the Assistant Legat at Bonn on 3/21/64, in connection with the case captioned "Assassination of President John F. Kennedy, 11/22/63, Dallas, Texas," Bufile 62-109000. This interview was reported to the Bureau by airtel from Bonn dated 3/23/64.
