USSK Bagley made reference to information previously disseminated to the Bureau by CIN indicating that on 10/18/63, Oswald had contacted Valeriv Vladimirivich Kostikov, Soviet Embassy, Mexico City, on  $M \in \chi_1(O)$  9/28/63. At that time, Oswald inquired if there had been any response from Mashington, D. C., concerning a request which he apparently had made . He again contacted the Soviet Embassy on 10/1/63, concerning the same matter.
