Bureau airtel 4/23/64 instructed WFO to be alert through established coverage to the possible future visit by Mrs. MARGUERITE OSWALD to the Soviet Embassy. WFO has effected coverage through appropriate established sources such as lookouts, confidential informants and anonymous sources. (S)(u) D.C. TEXAS NY

The attached report is classified "Confidential" because it reveals our investigative interest in a representative of a foreign diplomatic establishment; and further because it contains information from WF T-1, a confidential source of continuing value, which if disclosed could tend to identify the source and thus compromise its effectiveness. (S)(u)

~~It is also classified "Confidential" to protect the identity of WF T-1 since disclosure of information attributed to PAUL BETHEL might ultimately lead to informant's identity and thus compromise his possible future value.~~
