ADMINISTRATIVE

The bulk of file references at Mexico City regarding Subject are found to be CIA information reports classified "SECRET" not to be disseminated outside the Bureau, and pertain to Subject's activities in connection with his official duties as Cuban Ambassador. However, one such report, Number 7825, dated 5/13/64, may be of interest to the Bureau, if not already furnished by CIA, in view of recent developments. It is set forth verbatim herein: (S)(U)

"LEE HARVEY OSWALD, IS - R", Bufile 105-82555, Mexico City file 105-3702, which transmitted information regarding telephonic conversations between Subject and OSVALDO DORTICOS, President of Cuba, regarding the arrest of SILVIA DURAN, an employee of the Cuban Embassy in Mexico, D. F., by Mexican authorities. Translations of these conversations are enclosures to Bureau airtel to Dallas, San Antonio and Mexico City dated 1/13/64 in the OSWALD case. (u)

Should Subject defect from the Cuban regime, his knowledge of the actions of the Cuban Government at the time of the assassination of President KENNEDY could be invaluable. (u)

Bulet dated 6/10/66 captioned "ERNESTO 'CHE' GUEVARA, IS - CUBA", Bufile 105-19305, enclosed CIA Report # 00-K-323/08627-66 dated 5/20/66. This report indicated the Subject was a close friend of "CHE" GUEVARA and described the Cuban Embassy, Mexico, D.F., as a center of subversive activity. (u)

Concerning the plot to kidnap Subject during December, 1966, on 12/23/66 the CIA Station, Mexico, D.F., advised that Subject was scheduled to fly to Cuba that date for the holidays and was not expected back in Mexico City until early in January, 1967. On 1/4/67 CIA advised departure delayed until mid-January. (u)
