EVGENI V. BUGROV to JOHN GUTHRIE, State Dept. stating that relative to their previous conversation, we are sending KONSTANTIN I. ZOTOV and ARKADI P. VERGEI to Boston tomorrow. (to see YURIA ASSEEV). BUGROV said that he promised to tell GUTHRIE the situation. GUTHRIE said that he would like to hear from BUGROV when they get back as to what they have found up there. BUGROV said let them go tomorrow and he will call and tell the departure time a little later. OK. jel

EVGENI V. BUGROV to ARKADI P. VERGEI inquiring as to whether he had any plans for tomorrow. He asked if he could come to Emb. as soon as possible (tomorrow). VERGEI said that he had nothing planned as yet. BUGROV said that he would be going to Boston along with ZOTOV (KONSTANTIN I.), because of YURI ANNEK ASSEEV being in hospital there, and that it would be necessary to leave tomorrow morning. OK. BUGROV added that he should see ZOTOV and he'll explain everything to VERGEI. OK. (Russian) jel

NIKOLAI G. REZNICHENKO to Dutyman wanting to know if anyone asked for him. No. He told REZNICHENKO that EVGENI (EVGENI V. BUGROV?) left a package on the table downstairs (at Emb.) that he wanted REZ to take with him (to NY?). REZ said he knew about this; that he will be at the Emb. tomorrow morning early, as he and KARPOVICH (BORIS V.) will be going to NY by car tomorrow. Dutyman wanted to know if he planned on coming by Emb. today, and informed in about 2 hours he'll be there. OK. (Russian) jel

IVAN F. AKULOV to wife of ARKADI P. VERGEI (TAMARA A. VERGEI) asking that she pass on to her husband that his father was preparing to have an operation. He explained that there was a telegram to VERGEI to this effect. TAMARA obviously received this information rather hard, as she burst into tears. (Russian) pwm

SERGEI N. VISHNEVSKI to ALEKSANDR A. KOKOREV, doorman at the Embassy, asking for the phone # of GENNADI G. DEREVENSKOV. He was given the number 779-7248. OK. (Russian) pwm

SERGEI N. VISHNEVSKI to GENNADI G. DEREVENSKOV, who has apparently been sick. DEREVENSKOV said that Dr. VERGEI (ARKADI P.) had visited him today and that he has no temperature at the present time, but has not eaten anything today. They discuss DEREVENSKOV illness at some length and then VISHNEVSKI tells DEREVENSKOV about VITALI V. PETRUSENKO being here and looking for furniture. DEREVENSKOV said he

VISHNEVSKI to DEREVENSKOV:
he had requested a vacation so he could rest awhile. VISHNEVSKI said he knew this. VISHNEVSKI indicated he had wanted one day. VISHNEVSKI says he is considering the end of May or first of June. PETRUSENKO then came to the phone and talked to DEREVENSKOV, again going over DEREVENSKOV's illness and then PETRUSENKO mentioned he had been to the office (Tass ?) for a short while already. (Russian) pwm

VITALI V. PETRUSENKO to VLADIMIR V. VASHEDCHENKO, who told PETRUSENKO that this morning he had read the newspaper and then took a walk, meeting some friends and then decided to go to see Fort Washington, not far outside of Washington, and on the way stopped at the Tass Office to check on his work. He returned about 40 minutes ago. PETRUSENKO said that he had read about JACK RUBY (ph) in Dallas yesterday and that today he was taken by VISHNEVSKI to see both the Senate and the House of Representatives and then went with the children to see the airplanes in Smithsonian Institute. VASHEDCHENKO suggested PETRUSENKO, as both VASHEDCHENKO and his wife will be at home. OK. PETRUSENKO agreed to come over a little later. (Russian) pwm

VISHNEVSKI excused himself, stating that he had a friend visiting him from New York City, that he had not seen for a long time, and that he couldn't be so impolite as to leave him. He suggested that they meet some other time. OK. (PETRUSENKO, VITALI V., the friend from New York ?). pwm
