Lakeland, Fla.
November 24, 1963

On November 23, 1963, there were six members of the Forrest Club #11, United Florida Ku Klux Klan of Lakeland met on the property of H. W. GRINES near Highway 39 and #4 on which the group has been holding regular meetings.

The purpose of the meeting was to start work on a klavern for the group.

Those recognized were:

H. B. BASIL
DONALD JOHNSON
H. W. GRINES
MARTIN GRINES
O. V. BEATWRIGHT
N. F. BYRD

The men worked for a short time until the lumber they had was used up. JOHNSON said he was going to try to get the club to buy all the lumber they need to finish the building.

BEATWRIGHT and JOHNSON said they thought the Klan should call off the Klan rally to be held in Plant City on that same day. They said they thought it would not look good because of the death of Mr. KENNEDY. 11
