The rally was opened with a prayer by O'PRY. There were three speakers and three crosses were burned.

The first to speak was O'PRY and he said the klan needed everyone to help with the fight to keep Negroes from mixing with the white children and mixing of all kinds. He told of chasing a Negro from a store near his home until he (O'PRY) was through buying his groceries. He challenged any preacher to face him and tell him it is God's will to integrate. O'PRY introduced FNU NOUCE as the next speaker.

NOUCE has spoken at several klan rallies and he said he understands the way the Southern people feel about mixing.

There was not much said about the death of JACK KENNEDY, but it was said the klan was not to run him down, but his stands on integration would be talked about.

JASON KERSEY told the group the United Florida Ku Klux Klan is a part of the real klans and is not an outlaw
