Memorandum:

There was a meeting of the Tampa chapter, National States Rights Party, held at Party headquarters in the Drew Park section of Tampa on the evening of December 6, 1963. Eight persons were in attendance, these being:

A woman brought to the meeting by the VEASEYS, about 50 years of age, said to have come to the meeting for introduction to TAFT, as a possible "girl friend"

The meeting consisted of general discussions.

TAFT stated that J. B. STONER is expected to be in Florida during the month of December, and will probably speak at the NSRP meeting at Tampa on Friday night, December 13th. He requested that each person in attendance bring a friend to this meeting so that there will be good attendance next Friday.

TAFT predicted that, after STONER makes a few speeches in Florida, and after NSRP groups are organized in Plant City and Lakeland in the near future, the NSRP as a whole will be at least ten times stronger than it now is.

TAFT said that he is in process of writing a letter to the editor of one of the Tampa newspapers complaining about the fact that said newspaper has placed the blame for President KENNEDY's assassination on the "right wingers" instead of on the "left wingers".

There was discussion concerning the fact that President KENNEDY was "no good", that President JOHNSON will be the same, and it was generally agreed that things will be "no good" until the 3rd Party (NSRP) moves in and elects some candidates.
