Rewles on 11/12/64 requesting that Rewles again get in touch with Legat, London. As of 12/10/64 Legat, London received no reply form Rawles, however, it is noted Rawles is a seamen and is at sea a considerable part of the time. Legat. London indicated, from post experience, that in all probability hawles would communicate with loget, London and this matter is being followed.
