On or about March 24, 1969, Sol G. Ortiz, 430 Gardina Street, San Antonio, Texas 78201, received a pamphlet entitled "The Libertarian American," Vol. II, No. 2, dated March, 1969, which was postmarked at San Antonio, Texas, on March 23, 1969.

The pamphlet indicated (on page 5) that the Libertarian American was published by the CENTER FOR LIBERTARIAN STUDIES, Box 2524, San Antonio, Texas 78206, an independent affiliate of the ALLIANCE OF LIBERTARIAN ACTIVISTS of Berkeley, California. It indicated that Editorial Offices were located at 227 Harrison Avenue, San Antonio, Texas 78209.

Pamphlet further indicated that the Libertarian American is dedicated to the liberation of the individual from coercive institutions and ideologies. It is committed to the development of a THIRD FORCE free from the statist polemics of both left and right.
