Lakeland, Fla.

Feb. 3, 1964

There was a meeting of the National States Rights Party at 119 West Patterson St. in Lakeland, Fla. at 3:00 p.m., Feb. 2, 1964.

There were seven present and those recognized were:

- Mr. and Mrs. C. L. SHEFFIELD - Lakeland
- G. P. STUBSILL - Lakeland
- O. V. BOATWRIGHT - Lakeland
- DAVEY TAFT - Tampa
- DAVE STACY - Tampa
- ED. PARKER - Tampa

SHEFFIELD played three records by WALLY BUTTERWORTH of the Veterans and Buyers League: (one was on the death of President KENNEDY; second said there would be a march on Washington by the white people on Feb. 22, 1964; third said not to give up firearms to anyone because the Americans have a right to bear arms.

TAFT asked the group if they wanted to try to meet again next week or just call the meetings off. He said he could not come from Tampa if there was not going to be any more present than seven. The group agreed to try another week.

TAFT said he has already gone in debt for the party and he cannot stand much more.
