> The Bureau has also classified the enclosed memorandum "Secret" on the basis that this information came from NY 5812-S\*, a highly sensitive source, and that unauthorized disclosure of this information could cause serious damage to the internal security of this country.

For your added information, a copy of this memorandum was disseminated by the Bureau to the State Department, United States Secret Service and also to the Department of Justice.
