SMALL DESCRIBED BY INFORMANTS AS BOASTFUL AND EGOTISTIC AND INCLINED TO LEND GREATER IMPORTANCE HIMSELF THAN JUSTIFIED. NO INFO DEVELOPED THAT HE ACTUALLY KNEW OSWALD OR EVER SAW HIM IN MEXICO AND HIS COMMENTS IN THIS CONNECTION ARE NOT SUSCEPTIBLE OF FURTHER VERIFICATION BUT SHOULD BE INTERPRETED IN LIGHT OF HIS PERSONALITY.
