On 4/22/64, NY 3785 (S) who has furnished reliable information in the past, advised SA ROBERT T. GOREY the following information:

The informant stated that when Dr. PALADE's sister visited the US from Brazil last year she went to Boston, Massachusetts to have an ear operation and in Boston stayed with Dr. MIRCEA POTINO, 4 Franklin Avenue, Cambridge, Massachusetts. (S)

Informant stated that he learned this information from Dr. RADU MAVRODINEANU (S), age 53-54, who recently moved from Yonkers, New York, to Teolonia, New York, where he is employed as a research chemist for Philip's Laboratories. (S) Dr. MAVRODINEANU also told the informant that Dr. PALADE's sister refused to meet Dr. MAVRODINEANU's wife and others during her visit in the United States, apparently out of fear that her contact with them would be discovered by the Brazilian authorities. (S)

Informant said that Dr. MAVRODINEANU (S) is a friend of EMBRI PARCASSANU (S) of Washington, D.C., and also with NICOLAE CARINFIL (S). Informant believed that CARINFIL's (S) wife is a sister of Mrs. MAVRODINEANU's father, GEN. PARATOGHI (S) who is now deceased, but who was a former Royal Romanian Army Commander in the Bukarest area. (S)

Informant advised that he has not seen HIRCEA POTINU since Dr. PALADE's disappearance to the United States. He described POTINU as a brilliant young atomic physicist who desires to get his mother out of Romania on a visit to the US. (S)

Informant advised that Dr. PALADE, Dr. MAVRODINEANU, and Dr. POTINU are all anti-Communists who are members of former elite Romanian families. (S)

The informant advised that he occasionally visits Dr. ION COCICBA, whom he described as an intelligent individual who originally came from Transylvania. He stated that Dr. COCICBA told him that he had sent (radio, a tape recorder, a television set, and even a car, possibly of Czech make) to relatives in Romania. Dr. COCICBA stated that he paid \$1,000 for the car and \$200 to \$300 for customs tax. (S)

Informant stated that he learned from COCICBA that his mother is coming to the United States on a visit. (S)

Informant could not furnish any information on Dr. GYIDIU POPESCU or his wife, MANDICA ANTONICA, and his wife, ION BASCHIRU, or LEE HARVEY OSWALD. (S)

Regarding Dr. RADU MAVRODINEANU, a review of NYO files reflect the following information: (S)

In addition, [MAVRODINEANU had another listed reference, namely 105-55916-25, Page 3] (S) which was not available during the time of the search. (S)
