MARK LANE SECURITY MATTER -

On 4/26/68 BILL ALEXANDER, Assistant District Attorney, Dallas County District Attorney's Office, was contacted regarding Dallas Case Number 87-16,802 (specifically subject Andrew John A. Polomsky).

During the course of the interview, ALEXANDER asked "The Character MARK LANE" is of any interest to the Bureau ?
