MANUEL ROSALES MIRANDA, Director, Preliminary Investigations, Mexican Federal Attorney General's Office was contacted and furnished ~~with~~ the information that reportedly agents of the "JUDICIAL" had picked up a passenger list for Flecha Roja for 9-26-63. He stated he would check into the matter. & u

On 4-1-64 MANUEL ROSALES MIRANDA and Col. HECTOR HERNANDEZ TELLO, Chief of the Federal Judicial Police both advised that they had no information concerning this matter and that none of their people had obtained these lists. & u

(Col. HERNANDEZ TELLO surmised that DFS men might be involved) & u
