On 3/22/64, the informants ascertained that ELIZABETH MORA had now started giving out the current "Party line" in the story regarding the LEE HARVEY OSWALD case. She indicated that she believed now that OSWALD was "an odd ball" who probably was collaborating with JACK RUBY and the police officer OSWALD was said to have killed. She claims that Police Officer TIRRA/TI was in RUBY's nightclub with OSWALD a few nights prior to the shooting. (u)

The informants noted that MORA is now apparently putting out of her mind the things that had previously worried her and was minimizing her concern about VINCENT LEE when she traveled with him from CUBA, and she hazily refers to her attempt to talk to LEE in Cuba "about New Orleans." (u)

Informants mentioned that ELIZABETH MORA had gone to Washington, D. C., sometime during that period because she had said she was in Washington during the time ADOLFO LOPEZ MATEOS was elected President of Mexico. MORA's mother corrected her and then she became confused and said it was ADOLFO RUIZ CORTINES. According to the informants, this became patently wrong also and then she said she now remembered that it was from something someone had written to her. (u)

The informants recalled that MORA had gone to Washington, Chicago, and New York shortly before she made her application for Mexican citizenship. They did not know whether she had gone to New Orleans. (u)
