# Memorandum

Assaulting or Killing Federal Officer

NO 1227-C-TE (Former) was an excellent informant while in New Orleans. During the time he was a ~~former~~ CI and TE he did work for G. Wray Gill the well known New Orleans criminal attorney. This informant left New Orleans in 1965 to return to his home in Lincoln, Illinois where he is not affiliated with the criminal element and has a respectable job in the Credit Bureau business...

On the evening of 2/26/67 informant called the writer at his home. This is not unusual as TE calls frequently strictly on a friendship basis. On the 2/26/67 call he talked about having known Dave Ferris casually when Ferris was doing work for G. Wray Gill. TE said ~~he~~ Ferris was a homosexual, took pep pills and lived in a dream world and continually discussed "wild schemes" and in effect attempted to give the impression of being a "soldier of fortune". He never discussed an assassination plot of any kind with informant.

Informant stated the reason for his call was to advise that a person who would know a lot about Ferris activities and movements during 1963 would be a Morris Brownlee whose last known address to informant was 4728 Jefferson Highway, New Orleans. He said Brownlee was a homosexual, dope addict and who had worked for G. Wray Gill doing investigations in 1963 to work off money owed Gill for a narcotics charge that Gill had helped him on....

Indices shows two references to Brownlee. One is 89-69-702 concerning a RD 302 interview with NOPD Vic Sqd. Detective Fred O'Sullivan who during the interview said that a Morris Brownlee of Jefferson Highway would know background on Dave Ferris. The other reference is 173-99-7 showing that a Morris Brownlee of 4728 Jefferson Highway was one of those arrested by the NOPD at the Quorum Club Esplanade Ave. in July of 1964....
