~~311185~~On 12/6/63, MEX-18 and MEX-19 orally furnished the following information to the writer: ~~A~~

ELIZABETH MORA, according to informants, is still very upset and excited over the involvement of LEE HARVEY OSWALD as the reported assassin of President Kennedy. She indicated that the Communist Party of Mexico is very interested in obtaining all of the information available concerning OSWALD's travel to Mexico and particularly how much the American authorities know. ~~A U~~

ELIZABETH MORA requested informants urgently to furnish her any newspaper clippings they can obtain regarding OSWALD's activities, especially relating to dates of his arrival in Mexico and departure from Mexico, as well as indicating who he has been in touch with. That request was made to informants by MORA the evening of 12/5/63. ~~A U~~

ELIZABETH MORA stated to informants that the only way OSWALD can be linked "to Mexico" was his activities before his trip to the Soviet Union, and she definitely wants information concerning the date he departed for Russia. MORA intimated that something had occurred at that time which was of significance although she did not reveal what it was. ~~A U~~

According to informants, MORA considered "terribly important" any press references to OSWALD's activities in New Orleans before he went to Russia, stating that if "something" regarding his activities at that time appeared in the press, it could "blow the lid off and we could all get fried." ~~A U~~
