It is noted that on page 2 of reWFO LHM, 1/7/64, JOSEFINA JIHINEZ MENDEZ, a Pan American Union employee, without giving basis for her feeling, stated she felt there was some connection between OSWALD, JACK RUBY and captioned subject. Insemuch as info from JIMINEZ was furnished in form suitable for dissemination, the Bureau may also desire to disseminate the enclosed.
