DEPARTMENT 1960 UNTIL 1970, ADVISED THAT HE RECEIVED A SECOND OF TWO TELEPHONE CALLS ON MARCH 10, 1989, FROM AN UNKNOWN FEMALE WITH A BRITISH ACCENT WHO ADVISED SHE LIVED IN BRIGHTON, SUSSEX COUNTY, ENGLAND, TELEPHONE NUMBER 0273-364-361, BUT REFUSED TO GIVE HER NAME.

GIARRUSSO ADVISED THAT THE UNKNOWN FEMALE CALLER HAD RELATED TO HIM THAT SHE WAS IN THE NEW ORLEANS AREA FROM 1966 UNTIL 1968, AND HAD WORKED ON A TEMPORARY BASIS FOR ABOUT TWO DAYS WITH AN ATTORNEY OF ITALIAN EXTRACTION, NAME UNRECALLED. WHILE WORKING FOR HIM SHE HAD TYPED A LETTER, CONTENTS NOT REMEMBERED, ADDRESSED TO THE MOTHER OF LEE HARVEY OSWALD, AND THAT MONEY WAS BEING SENT TO HER. REASON FOR THE MONEY TRANSMITTAL WAS UNCLEAR, BUT SEEMED TO HAVE SOMETHING TO DO WITH PRESIDENT KENNEDY'S ASSASSINATION. SHE HAD REFERRED TO ATTORNEY AS, "SLEEZE BALL" IN AN EARLIER CONVERSATION WITH THE COUNCILMAN'S SECRETARY, SAME DATE AND STATED THAT HE SHOULD HAVE BEEN INDICTED.

GIARRUSSO ADVISED THAT THE FEMALE CALLER FORMERLY HAD BEEN MARRIED TO AN AMERICAN AND HAS A TWENTY-ONE YEAR OLD SON ATTENDIG A LOCAL UNIVERSITY.
