IN REFERENCED PHONE CALL TO DALLAS, WMFO ADVISED THAT CURRENT LISTING OF HOME PHONE FOR MARK MANCINI IS 244-6396, HOWEVER DALLAS RECORDS REFLECT A HOME PHONE OF 462-0162, AS REPORTED IN DL 183A-1035. THE INFORMATION FROM THE DALLAS FILE IS DATED JUNE 18, 1965 AND WAS THE NUMBER MARCELLO LISTED FOR MANCINI IN THE VISITORS LIST AT FCI, TEXARKANA.

NEW ORLEANS AT NEW ORLEANS, LA, 1) WILL ATTEMPT TO IDENTIFY ANONYMOUS CALLER TO CITY COUNCILMAN JOSEPH GIARRUSSO THROUGH REVIEW OF INTERVIEWS CONDUCTED IN THE CLAY SHAW TRIAL. NEW ORLEANS SHOULD CONSIDER DEBORAH MILLINGTON AS HAVING A PRIOR MARRIED NAME WHILE RESIDING IN NEW ORLEANS;
