SUBJECT: ASSASSINATION OF THE PRESIDENT  
JOHN F. KENNEDY

On Saturday, 11/24/63, <sup>(C)</sup> ~~IN~~ [2266-S] who had furnished ~~(S)~~ reliable information in the past was contacted relative to the above captioned matter. Informant advised as follows:

Informant stated that on this date he had contacted several members of the staff of the Cuban Mission to the UN ~~(S)~~ and also a member of the Executive Committee of the Casa Cuba Club, a pro-CASTRO organization in New York City. ~~(S)~~ <sup>(u)</sup>

During these contacts, he was unable to uncover any information bearing upon this matter. Informant further related that he has no information at his disposal concerning this matter. Informant was alerted to immediately furnish any information that he received ~~and~~ bearing on any aspect of this case.
