ON 11/23/63, inquiry by SA Thomas R. HENRY, Jr., revealed that LAWRENCE WILLIE FUGATE, Rossville, Ga. (subject of AT file 157-149), and DOUGLAS DERWOOD DAWN, Rossville (subject of AT file 157-152), were at their respective residences between 5:00 PM and 5:30 PM, 11/22/63.

On 11/23/63, inquiry by SA CARL E. CLAIBORNE, at Atlanta Georgia, revealed that GEORGE MICHAEL BRIGHT (subject of AT file 105-944) was at his residence during the afternoon of 11/22/63.

On 11/23/63, BEN HUTCHINSON, Sr., President Tip Top Roofing Co., Atlanta, Georgia, advised SA LESLIE J. NONGARD that EARL ARINGTON ROBINSON (former bomb suspect, Knoxville Division) had been working for him all day 11/22/63, and he could state Robinson had not been out of the city on that date.
