The following investigation was conducted on 11/23/63, by SA HOWARD E. RICHARDSON to determine the whereabouts of CARY JOHNSON HANSEL (RH 157-75), a bombing suspect of this division:

Mr. WILLIAM J. BIEHL, JR., Agricultural Research Service, Personnel Relations Division, Washington, D.C., on 11/23/63, advised that CARY JOHNSON HANSEL worked on 11/22/63, at the Department of Agricultural Research Center, 701 LaMont St., N.W., Washington, D.C. He stated that he had personally determined that the guard records at this office reflect that HANSEL signed in at 8:00 a.m. and out at 5:30 p.m. that date. Mr. BIEHL further advised that he had determined through personal contact with a co-worker, Mr. JOHN KINGSOLVER, home telephone 585-5056, that HANSEL was present during the day the President was assassinated.

Mrs. EDWARD A. ROSE, Apartment 2, 1119 Peyton Randolph Rd., Falls Church, Va., on 11/23/63, advised that HANSEL who lives next door in Apartment 1, at that address, was at his residence early on the morning of 11/23/63. She did not see him on 11/22/63.
