GEORGE LINCOLN ROCKWELL, ANP.

Chief E.G. MCCAIN, PD Danville states he observed ROCKWELL in Danville at 9:30 AM 11/22/63. ROCKWELL visited office of Chief of Police.

LEE JAYNE, Piedmont Airlines, Danville, Va. stated ROCKWELL left Danville for Arlington, Va. by plane at 10:16 AM 11/22/63.

DAVE BUSH, Hotel Danville, Danville, Va. stated ROCKWELL left the hotel, room 808, just before 9:00 AM 11/22/63 and did not return. He understood ROCKWELL was going to Arlington. Said ANP members KARL ALLEN and ROBERT LOYD remained in Danville and he observed them leave hotel just prior to noon 11/22/63 and walk up main street.
