CG 6621-PC ADVISED THAT FOLLOWING RECENT GAMBLING RAID CONDUCTED IN ROSEMONT, ILLINOIS, BASED ON FBI WARRANT, CONTACT MADE WITH CHARLES GIANCANA, AKA CHARLES KANE, SAM GIANCANA'S BROTHER BY MAYOR OF ROSEMONT FOR PURPOSE OF HAVING KANE CONTACT BROTHER WITH REQUEST TO HAVE GIANCANA ORDER ROCCO POTENZO TO TAKE HIS VARIOUS OPERATIONS OUT OF ROSEMONT BECAUSE OF PUBLICITY BEING AFFORDED TOWN. CONTACT MADE WITH KANE BECAUSE OF LARGE FINANCIAL AND REAL ESTATE HOLDINGS IN THAT TOWN AND IT WAS POINTED OUT THAT THESE WOULD LOSE VALUE IF PUBLICITY CONTINUED. ⁴

INFORMANT ADVISED THAT POTENZO CONTACTED ROSEMONT MAYOR SEPTEMBER 28 LAST AND ADVISED THAT "THE CIGAR" TOLD HIM TO GET OUT OF ROSEMONT. POTENZO CLAIMED TO MAYOR THAT HE HAD BEEN OUT OF CHICAGO FOR SIX MONTHS AND WAS NOT AWARE OF THESE OPERATIONS BUT INDICATED THAT HE WOULD CLEAR OUT IMMEDIATELY. ^u
