CONTACT MADE THIS DATE WITH NEWLY DESIGNATED CG 6792-PC WHO HAS BEEN IN ALMOST DAILY CONTACT WITH SAM GIANCANA DURING PAST SIX MONTHS. MET GIANCANA THROUGH FRIENDSHIP WITH JOHN "HAIRCUTS" CAMPANALE. INFORMANT AWARE OF GIANCANA'S DAILY SCHEDULE PARTICULARLY AS TO ARRIVAL BACK IN CHICAGO FOLLOWING TRAVELS TO OTHER CITIES. INFORMANT ADVISED TO HIS KNOWLEDGE GIANCANA HAS SPENT LAST FOUR WEEKENDS OUT OF THE CHICAGO AREA AND KNOWS POSITIVELY THAT TWO OF THOSE WEEKENDS SPENT IN NEW YORK CITY. *u*

GIANCANA, CAMPANALE, SAM PARDE AND WIFE, BUTCH BLASI AND INDIVIDUAL KNOWN AS NICK, LAST NAME BELIEVED ZARDO, WHO IN WORDS OF INFORMANT IS LARGE WEST SIDE "BOOK." u

DURING COURSE OF EVENING INFORMANT ADVISED THAT ROSS PRIO MET WITH GIANCANA AT ARMORY LOUNGE, HOWEVER, NATURE OF BUSINESS UNKNOWN TO INFORMANT. INFORMANT ORIGINALLY MET CAMPANALE THROUGH JOHNNY MARSHALL (TRUE NAME MARSHALL CAIFANO) WHO IS CLOSE FRIEND OF INFORMANTS AND WHO INFORMANT IS WITH ON A MINIMUM OF TWO TIMES A WEEK. INFORMANT VERY CLOSE TO JOHN CAMPANALE AND HAS FURNISHED CONSIDERABLE BACKGROUND CONCERNING CAMPANALE. INFORMANT ADVISED CAMPANALE RECENTLY OPENED PIZZERIA IN WESTERN SUBURBS AND IS OPERATING BOOK; HOWEVER, LOCATION OF BOOK NOT KNOWN AT THIS TIME. CAMPANALE AND GIANCANA HAVE BOTH INDICATED ON SEVERAL OCCASIONS THEY PLAN A TRIP DURING THIS COMING WINTER PROBABLY TO SOUTH AFRICA AND HAVE QUESTIONED INFORMANT AS TO POSSIBILITY OF HIS JOINING THEM ON THIS TRIP. u

NOTED DURING INTERVIEW OF GIANCANA IN PRESENCE OF ENTERTAINER JOE E. LEWIS DURING APRIL 1964 THAT GIANCANA INDICATED TO LEWIS THAT HE DESIRED MAKING SUCH A TRIP TO SOUTH AFRICA. u
