CG 6576-C* ADVISED SAM ROSA, CLOSE ASSOCIATE OF SAM GIANCANA, RECENTLY MET WITH PAT MARCY FOR PURPOSE OF HAVING MARCY OBTAIN PERMIT TO CHANGE "FAG" BAR THAT ROSA OPERATES INTO STRIP JOINT. MARCY, AFTER LEARNING ROSA HAD NOT PREVIOUSLY CLEARED THIS WITH GIANCANA, INSTRUCTED HIM TO DO SO BEFORE GOING FURTHER IN MATTER. WHEN GIVEN THESE INSTRUCTIONS ROSA QUESTIONED WHETHER HE SHOULD SEE GIANCANA OR "TEETS" BATTAGLIA. THIS INDICATES SOME SUBSTANTIATION OF RECENT INFORMATION REFLECTING BATTAGLIA ASSUMING MORE POWER, IT BEING NOTED ROSA NOW DAILY GOLFING COMPANION OF GIANCANA AND SEEMINGLY WOULD KNOW WHO HAS POWER TO OK SUCH TRANSACTIONS. MARCY INSTRUCTED ROSA TO SEE GIANCANA RE THIS STATING THAT IS THE WAY MARCY HAS INSTRUCTIONS. ✓
