K.XKASTEL about KASTEL's desire to secure a license at the Tropicana in Las Vegas. HEGEMAN said it was his belief BILTZ et that time was very close to former U. S. Senator PAT Der MC CARRAN and was probably representing him in this matter. HEGEMAN said that of his own knowledge he did not know whether BILTZ met CARLOS MARCELLO through KASTEL but assumed that he did. U.S.A. HEGEMAN said he could not clarify any further the connection between MARCELLO and BILTZ and he could furnish no further data about BILTZ. HEGEMAN said, however, that hoodlums today select front men to arrange meetings who are not suspected of underworld connections by law enforcement agencies.
