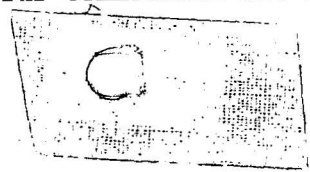

PCI JOSEPH HEGEMAN on contact June 26, 1962, advised that NORMAN BILTZ and his wife took a Caribbean tour approximately four or five years ago and on that occasion appeared in New Orleans, Louisiana where BILTZ contacted P. K. KASTEL about KASTEL's desire to secure a license at the Tropicana in Las Vegas. HEGEMAN said it was his belief BILTZ at that time was very close to former U. S. Senator PAT MC CARRAN and was probably representing him in this matter. HEGEMAN said that of his own knowledge he did not know whether BILTZ met CARLOS MARCELLO through KASTEL but assumed that he did. U.S.A.

HEGEMAN said he could not clarify any further the connection between MARCELLO and BILTZ and he could furnish no further data about BILTZ. HEGEMAN said, however, that hoodlums today select front men to arrange meetings who are not suspected of underworld connections by law enforcement agencies.
