This tavern is located under the same roof with two other taverns and lounges, which were owned by JOE MILLSTEIN, a Shylock. He understood MORRISON is a silent partner in the operation and that DARA is at the tavern every night.

MM 819-C* on 8/23/62, furnished information that JOSEPH INDELICATO made an appearance at the Harold Solomon Bail Bond Office in Miami Beach and in a discussion, GEORGE LEVINE related that the operators of the Hotel Ambassador in the Dominican Republic wanted a quarter of a million dollars for same and that he was going to New York and then to the Dominican Republic to look it over.

MM 833-C on 8/15/62, advised that the Hotel Ambassador, Santo Domingo, has 175 rooms.

MM 814-PC on 8/23/62, advised he heard that BING WEINSTEIN, an associate of MAX EDER (Miami 92-467) who did an extensive bookmaking business at the Fontainebleau Hotel the winter season before last, is in a mental hospital.
