WILLIAM KENNEY, Departmental Attorney at Miami, advised on 9/12/62, that ABE BROWN, (Miami File 162-30) and BEN NOVACK, President of the Fontainebleau Hotel, Miami Beach, Fla., recently purchased Federal Wagering Tax Stamps.

MM 509-C on 9/4/62, advised that JACK FRIEDLANDER, (Miami File 162-93) who quit a Las Vegas, Nevada casino gambling job to return to Miami and then take a casino gambling job in the Grand Bahama Islands, which is expected to open up soon, is still in Miami. He learned SAM WEISS, a bookmaker, shylock and liquor store operator has expressed a desire to bankroll FRIEDLANDER in anything that may appear profitable to him after he looks things over in the Islands. WEISS recently started a new cigarette vending machine company, known as the Dixie Vending Co., in Miami, and is seeking business from the hoodlum element.

This source also advised that JAMES PALMAISANO, (Miami File 92-503) recently returned to Miami from New York City, where he had been associating with JOHN ODDO, (Miami File 92-402) in ODDO's bookmaking, gambling and shylock operation.

In addition this source related that WILLIAM GUSTAV BISCHOFF, (Miami File 92-89) plans to leave for the Grand Bahama Islands in the near future.
