WEEKLY SUMMARY

On 10/15/62, Agents observed HYMAN MARTIN (Miami file 92-218) meet ELI QUAIN at Miami Beach and thereafter meet HOUSTON T. "RED" RAINWATER (Miami file 162-90) at Pier 5 in Miami. MM-806 PCI and MM-606 PCI advised that ELI QUAIN also known as the "Fruit Man" collects money from bolita operators and bookmakers for protection from law enforcement in Dade and Broward Counties.

MM-833 PCI on 10/17/62, advised that JOE STRAUSS's brother, ROBERT STRAUSS, aka RUBY STRAUSS, a bookmaker, visited with JOSEPH INDELICATO (Miami file 92-404) at the Beaux Arts Apartments, North Bay Village, Fla., on that date. On same date, GEORGE HYMAN LEVINE, known as an associate of SALVATORE GRANELLO (Miami file 92-442) visited INDELICATO at the Beaux Arts Apartments.

This same source advised on the same date that CHARLES TOURINE (Miami file 92-106) returned to his residence at the Beaux Arts Apartments on that date or the previous evening.

JOSEPH MASSEI (Miami file 92-122) has been at the Arlington Hotel, Hot Springs, Arkansas, since 10/1/62. His office at Miami Beach is closed in his absence.

MM 609-C on 10/11/62, advised as a result of an FBI inquiry at a printer in Miami, relative to football parlay cards, HARRY YATES (Miami file 165-26) at present has no cards. On 10/18/62, this source advised the bookmakers are puzzled as to why the FBI is interested in the football parlay cards, since they are printed locally. He stated as a result of the FBI inquiry the runners who distribute these cards find the cards harder to secure, even though there are still readily available cards in this area.

MM 509-C on 10/10/62, advised that on 10/6/62 and 10/9/62, HYMAN MARTIN was driven to and from the Patio Bridge Club, Miami Beach, by JERRY FISHMAN (166-43). While there MARTIN played bridge with IZZY BECK, MANNY BERMAN, and MAX MILLER. FISHMAN played the card game called "Million" with JIMMY COPPOLA at \$25.00 a game.

This source said also that SOL EDER , brother of MAX EDER (Miami file 92-467) and AL DEUTSCH, a bookmaker and gambler, have acquired the coctail lounge in the Cadillac Hotel, Miami Beach, and intend to use same for a bookmaking and shylocking operation. MAX EDER, he learned, supplied the funds for SOL EDER.

In addition, this source related he was told that a New York group interested in gambling and bookmaking control the distribution of football parlay cards in the Miami area and the New York representative is JOSEPH INDELICATO, who receives a percentage of the action on the cards, although he neither handles or has anything to do with the actual distribution of same.
