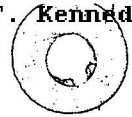

GUS ALEX, AKA., AR, DAILY SUMMARY.

PCI CHARLES POSTL ADVISED YESTERDAY THAT ALEX WAS AT POSTL-S HEALTH CLUB ON THE AFTERNOON OF JULY THIRTIETH LAST HAVING HIS USUAL WORKOUT AND STEAM BATH. CLAIMS ALEX STILL FREQUENTS THE CLUB ON THREE OR FOUR OCCASIONS A WEEK WHEN IN TOWN. ALSO VISITING THE CLUB ON A REGULAR BASIS ACCORDING TO PCI IS EDWARD VOGEL AND PHIL ALDERISIO. OCCASIONALLY LES KRUSE STOPS IN TO SEE ALEX OR SOMEONE ELSE BUT IS NOT A MEMBER OF POSTL-S AND DOES NOT WORKOUT THERE ALTHOUGH HE WAS A MEMBER SEVERAL YEARS AGO. CLAIMS VOGEL RECENTLY RETURNED FROM HONOLULU WHERE HE IS ATTEMPTING TO PLACE HIS DAUGHTER IN COLLEGE IN EFFORTS TO GET HER AWAY FROM THE UNFAVORABLE PUBLICITY WHICH HAS BEEN AFFORDED HIM IN THE PAST. ALSO CLAIMS THAT VOGIL IS DESIROUS OF DISASSOCIATING HIMSELF FROM MEMBERS OF THE HOODLUM ELEMENT WITH EXCEPTION OF ALEX BECAUSE HE HAS PLENTY OF MONEY, IS UP IN AGE, AND NOW WANTS TO LIVE A QUIET PEACEFUL LIFE.
