Mr. MANFRED STERN, German Consulate General's Office, 104 South Michigan Avenue, advised SAs COOK and DEWHIRST that DIETGARD ROSEMARIE FUEGER has valid German Passport Number B4019969 which was issued to her on October 16, 1961, and was valid until October 15, 1966. She was married in April, 1957, to HELMUT MAIER and has since divorced MAIER in Munich, Germany on May 25, 1961. She was originally admitted to the United States on September 17, 1957, as an immigrant having original Passport Number B0930642, which was issued to her on May 7, 1957, at Munich, Germany. Her current alien registration number is A10853180.

III. ACTIVITIES

CG T-2 advised that he had received information that ALEX as well as other Chicago hoodlums were greatly interested in securing business locations in "Old Town" area of Chicago. CG T-2 stated that since this area has been redeveloped lately and is now a tourist attraction, business establishments in the area are doing quite well financially, and that it is for this reason that ALEX and his associates are attempting to secure business locations in this area. CG T-2 stated that he did not know the names of any business establishments in the area which may possibly be owned by ALEX or other members of the criminal element.

CG T-7 advised that he had received information that five persons are exercising complete control of organized criminal activities in the Chicago area, and that these persons were SAM GIANCANA, TONY ACCARDO, PAUL RICCA, GUS ALEX, and a fifth person not known by CG T-7. CG T-7 further advised that he had heard that in the Loop area MURRAY HUMPHREYS is directly under ALEX in control, and that below HUMPHREYS is RALPH PIERCE and PIERCE is followed by PAT MARCY, Administrative Assistant to the First Ward Alderman.
