On December 14, 1972, the Surete Generale (SG), Beirut, Lebanon, advised there is no indication whatsoever that the subject is in Lebanon. The SG advised that stops placed by Interpol (Bureau of Narcotics and Dangerous Drugs) concerning subject remain in effect and that the Beirut office will be immediately advised when the subject enters Lebanon. The SG further advised that the subject will be placed under surveillance if he enters Lebanon. (S) (X) U
