MEX 170 advised 12/27/73 that he had confirmed that CAMILO RODRIGUEZ GONZALEZ, telephone 5-14-96-28, is currently residing at Calle Rio Lerma 144, Apartment 6, Colonia Cuauhtemoc, Mexico, D. F., Mexico. He was unable to locate a record of a Mexican passport issued to this individual tending to indicate that he has not traveled to the U. S. (R) u

MEX 287 advised 1/4/74 that subject was seen 11/10/73 at the wedding of the son of EDGAR KERNER, who is head of MGM for Mexico. Subject attended the wedding with his attorney CASTILLO and it appeared that they had been golfing. Reportedly subject invited his old card group to his home in Cuernavaca with their wives. The home was described as a large imposing residence with two entrances. This would appear to be the house in the Las Quintas area purchased from JERRY SCHULTZ. (R) u

Subject spoke of traveling to the Greek islands over Christmas. (DO NOT REPORT FOR DISSEMINATION) (R) u

It is noted that such travel would have put considerable distance between subject and RICHARD SCALZITTI CAIN, former associate, reportedly murdered in Chicago 12/20/73. (R) u
