Her maiden name is CRUMBLEY and she is originally from Kansas City, Missouri. She is the closest friend of actress LAUREN BACALL. She has been going with GIANCANA for the past 2½ years and is a very cultured person who is very romantically involved with GIANCANA. u

WFO is requested to check the records of the Passport Agency, Department of State, to obtain current information available there, including a current photograph of CAROLYN MORRIS, it being noted that information set out in remyairtel that she traveled to London, England, with Miss BACALL was confirmed by the New York Office. u

For the information of the Honolulu Office, the information set out in remyairtel that GIANCANA and Mrs. MORRIS intended to visit Honolulu over the New Years holiday was also confirmed by independent investigation by the New York Office. u

For the information of Legat, Mexico City, the New York Office determined that BOB LERNER currently resides next door to GIANCANA in Mexico, along side the Churubusco Country Club, Mexico City. (u) u

It is also noted that information has been received from CG 10838-PC that GIANCANA has a residence in the Pedregal section of Mexico City and another residence in Cuernavaca. u

The Los Angeles Office can discontinue the requested interview of PETER WITT, Agent of Miss BACALL. However, Los Angeles should now attempt interview of CAROLYN MORRIS in Santa Monica. She should be specifically requested to furnish all information concerning her travels with GIANCANA for the past 2½ years, including countries visited, residences maintained, associates, gifts to her from GIANCANA, source of any income available now to GIANCANA, and any other information believed to be of investigative interest, particularly any contact that he may currently have with leaders of organized crime. u
