ADMINISTRATIVE

The instant report is divided into three sections. The first is a series of excerpts taken from the file reviewing ALEX's rise to power. This was done with the purpose of attempting to identify a fresh approach on this case. The second traces ALEM's current activities. third section provides a thumbnail sketch of ALEX's reported employer, Apex Amusement, DeLuxe Cigarettes, and Ajax Phonographic. Virtually all of ALEX's reported income has been from this source. One again, it is speculated that if ALEX is to be brought to justice, that it will be necessary to attack him through this source. So long as this corporation insulates him from his illegal activities/income, it will be improbable to develop a prosecutable case. Chicago, therefore, intends to explore more the function and activities of the corporation as a means of reading ALEX.
