17. Remarks (By SAC):

It is recommended that this surveillance be maintained for an additional period of ninety days and such will be done UACB.

Obviously the quality and quantity of information received from this source has decreased from its peak three years ago, however, as is set out in number 9 it can be seen that information of interest to the investigations of this office continues to be obtained through this source. In addition, it is pointed out that there is no expense involved in monitoring this source for the reason that the same employees who monitor other surveillances on the same subject easily and with a minimum of effort monitor this source. It is further pointed out that there does not appear to be any risk involving the security of this source, except that risk which would necessarily be attained in any operation involving an entry to retrieve the microphone.
